A BILL

To direct the Secretary of Agriculture to designate an Agritourism Advisor, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Accelerating the
- 5 Growth of Rural Innovation and Tourism Opportunities
- 6 to Uphold Rural Industries and Sustainable Marketplaces
- 7 Act" or the "AGRITOURISM Act".
- 8 SEC. 2. FINDINGS; SENSE OF CONGRESS.
- 9 (a) FINDINGS.—Congress finds that—

1	(1) agritourism provides a range of unique ex-
2	periences to the public, including—
3	(A) education, such as school tours, garden
4	and nursery tours, winery tours, historical agri-
5	cultural exhibits, hops and microbrewery tours
6	and distillery tours;
7	(B) outdoor recreation, such as river ac-
8	tivities, mountain biking, horseback riding
9	wildlife viewing and photography, fee fishing
10	and hunting, wagon and sleigh rides, cross-
11	country skiing, game preserves, and clay bird
12	shooting;
13	(C) entertainment, such as concerts and
14	special events, culinary experiences, festivals,
15	fairs, interaction with farm animals, and wed-
16	dings;
17	(D) direct sales, such as on-farm sales,
18	farm stands, agriculture-related crafts and
19	gifts, u-pick operations, u-cut tree farms,
20	wineries, breweries, cideries, distilleries, and cut
21	flowers;
22	(E) accommodations, such as bed-and-
23	breakfast inns, farm and ranch vacations, yurts,
24	sheep wagons, and guest ranches; and
25	(F) dining on a farm;

1	(2) agritourism has financial, educational, and
2	social benefits to communities; and
3	(3) agritourism continues—
4	(A) to offer educational opportunities for
5	children and families;
6	(B) to generate supplemental income for
7	owners of agricultural enterprises, which are
8	often small or family-run businesses;
9	(C) to spur economic development in rural
10	communities;
11	(D) to preserve agricultural heritage;
12	(E) to help farms diversify; and
13	(F) to provide alternative revenue opportu-
14	nities to keep working farms in production.
15	(b) Sense of Congress.—It is the sense of Con-
16	gress that, to further realize the benefits of agritourism
17	to communities, the Secretary of Agriculture should incor-
18	porate agritourism into the Department of Agriculture
19	comprehensively.
20	SEC. 3. AGRITOURISM ADVISOR.
21	(a) In General.—Subtitle C of the Department of
22	Agriculture Reorganization Act of 1994 (7 U.S.C. 6941
23	et seq.) is amended by adding at the end the following:
24	"SEC. 237. AGRITOURISM ADVISOR.
25	"(a) Definitions.—In this section:

1	"(1) Advisor.—The term 'Advisor' means the
2	Agritourism Advisor described in subsection (b).
3	"(2) State.—The term 'State' means—
4	"(A) each of the several States of the
5	United States;
6	"(B) the District of Columbia; and
7	"(C) any territory of the United States.
8	"(b) Advisor.—The Secretary shall designate a sen-
9	ior official in the Office of the Under Secretary for Rural
10	Development to serve as the Agritourism Advisor.
11	"(c) Duties.—The Advisor shall encourage and pro-
12	mote, in each State and on land under the jurisdiction
13	of Indian Tribes (as defined in section 4 of the Indian
14	Self-Determination and Education Assistance Act (25
15	U.S.C. 5304)), agritourism activities and agritourism
16	businesses, including—
17	"(1) educational experiences;
18	"(2) outdoor recreation;
19	"(3) entertainment and special events;
20	"(4) direct sales;
21	"(5) accommodations; and
22	"(6) any other activity or business relating to
23	agritourism, as determined by the Secretary.
24	"(d) Means of Achieving.—In carrying out sub-
25	section (c), the Advisor shall—

1	"(1) coordinate with the agencies and officials
2	of the Department;
3	"(2) advise the Secretary on issues relating to
4	agritourism;
5	"(3) ensure that the programs of the Depart-
6	ment are updated to address best agritourism prac-
7	tices;
8	"(4) conduct outreach to stakeholders and co-
9	ordinate external partnerships to share best prac-
10	tices, provide mentorship, and offer technical assist-
11	ance to agritourism businesses;
12	"(5) facilitate interagency program coordination
13	and develop interagency tools for the promotion of
14	agritourism programs and resources;
15	"(6) review and improve farm enterprise devel-
16	opment programs that provide information about fi-
17	nancial literacy, business planning, and marketing
18	for agritourism;
19	"(7) coordinate networks of agritourism busi-
20	nesses;
21	"(8) consolidate access to Federal resources to
22	help agritourism businesses effectively navigate
23	available programs and assistance; and
24	"(9) collaborate with other Federal agencies, as
25	needed.".

- 1 (b) TECHNICAL AMENDMENT.—The Department of
- 2 Agriculture Reorganization Act of 1994 is amended by re-
- 3 designating the first section 225 (7 U.S.C. 6925) (relating
- 4 to the Food Access Liaison) as section 224A.
- 5 (c) Conforming Amendment.—Section 296(b) of
- 6 the Department of Agriculture Reorganization Act of
- 7 1994 (7 U.S.C. 7014(b)) is amended by adding at the end
- 8 the following:
- 9 "(11) The authority of the Secretary to carry
- out section 237.".
